

# Fact Sheet:

## PUBLIC ACCESS AT 2TG - Personal Injury Claims



### About us

2TG barristers are regulated by the Bar Standards Board (BSB). A link to the Barristers' Register on the BSB's website can be found [here](#). The Register shows who has a current practising certificate and whether the barrister has any disciplinary findings, which are published on the Register in accordance with BSB policy. Our barristers can advise and represent you if you have had an accident or suffered an injury in the UK or overseas which was not your fault. ### Timescales

Timescales for a case will vary depending on a number of factors including the barrister's availability at the time of the enquiry, the type and complexity of the case, the other side's approach and when the court is able to list your case for hearing (if applicable). We may be able to provide you with an indication of when your hearing is likely to be heard by the relevant court on a case-by-case basis.

Our clerks will provide you with estimated timescales for written work, including advice or drafting/amending documents on a case-by-case basis within 7 days of your enquiry, but we are often able to provide this information much sooner.

### Fees

Our barristers charge either an hourly rate, daily rate or fixed fee depending on the type of work involved. For example, written work tends to be charged hourly, but we are able to agree fixed fees. Attendance at court hearings will always be charged as a fixed fee. We do not work under Conditional Fee Agreements for Public Access cases. Please find below estimates based on the ranges of fixed fees for barristers at 2TG who specialise in personal injury cases. All fees are subject to the addition of VAT where applicable.

The fees that you are charged for your case will depend on the seniority of the barrister instructed, and the complexity and urgency of the case. For particularly urgent or complex cases, fees may be outside of the range provided below. Hourly rates range from £150 to £250 per hour. The fees estimates provided are applicable to cases up to the value

of £25,000 and are provided for members of chambers up to 15 years call. For higher value cases, or if you wish to instruct a more senior barrister or QC, please contact the clerking team.

Written advice on your claim	£600 - £1,000
Drafting statement of case	£600 - £1,000
1 day trial (claim not more than £3,000)	£500
1 day trial (claim more than £3,000, but not more than £10,000)	£710
1 day trial (claim more than £10,000, but not more than £15,000)	£1,070
1 day trial (claim more than £15,000, but not more than £25,000)	£1,705
